The following disclosure is required by the federal Electronic Signatures in Global and National Commerce Act (E-SIGN Act). Please read this E-SIGN Disclosure carefully. You agree that you are the person providing the consent, as well as the person executing any documents delivered to you electronically. No document may be executed by another person on your behalf.

### ***Types of Documents that will be Provided in Electronic Form***

The documents provided electronically may include, without limitation, disclosures required by various federal and state laws and regulations. The documents may also include any other information, agreements, disclosures and notices that we wish to provide you in an electronic form, even if they are not required by laws or regulations.

### ***Your Right To Receive Paper Copies of the Documents***

You are not required to provide your consent in order to receive products or services from us. If you prefer not to provide your consent, all of the documents will be provided to you in a paper form. If you decide to provide your consent, you may receive paper copies of the documents as described in “*How to Receive Paper Copies*” below.

### ***Your Right To Withdraw Your Consent***

### ***Scope of Your Consent***

### ***Withdrawal of Your Consent***
